| EVENT CONDITIONS |

1. In these Event Conditions:-

“TTTA” means Townsville Table Tennis Association Inc and where the context permits, includes its respective administrators, directors, agents, officers, officials, committee members, volunteers, employees, other participants, any sponsors, advertisers and if applicable, owners and lessors of premises on which the sport takes.

you” or “your” means the member named in the Registration Form and wherever relevant, includes such members minor child, personal representatives, assigns, heirs, and next of kin.

2. The tournament will be held under Table Tennis Australia (TTA) and International Table Tennis Federation (ITTF) rules & regulations.
3. You must be a registered member of clubs/associations affiliated with Table Tennis Queensland (TTQ), TTA or ITTF.
4. Each match will be controlled by an umpire whose decision will be final on point of fact. The decision of the referee or deputy referee will be final on point of law.
5. Events 1 & 2 will be best of seven games at semifinal stage. All other events will be best of five games.
6. Age limits for junior events as at 1st January 2016 apply. Veterans must be of age on 31 December 2016. Fixture attendance eligibility criteria as set in the By-Laws will apply for the Closed Championship.
7. First round in all singles events will be played in a round robin format where possible.
8. ITTF approved 3-star white plastic balls will be used.
9. Entry fee must be paid upon arrival at the centre by you and before the tournament commences.
10. You must ensure that you doubles partners has submitted a separate Registration Form. If a partner is required, show ‘required’ in the space provided.
11. Losing players to umpire: No player may leave the centre before umpiring without approval of the tournament referee.
12. Players not available when called for an event may be disqualified.
13. The organizing committee reserves the right to refuse you any entry in any event.
14. Late entries may be accepted at the discretion of TTTA.
15. TTTA reserves the right to cancel or combine events in which insufficient entries have been received without prior notification to you and other participants.
16. Seeding for all events (and acceptance of any nominations) is at the discretion of the TTTA Selectors.
17. You understand the nature of table tennis activities and are aware that participating in a sport such as table tennis is potentially hazardous activity and contains risks. These risks may be caused by you and/or your minor child's own actions or inaction, or the actions or inaction of others participating in the sport. There may also be other risks and social and economic losses either not known to you or not readily foreseeable at this time and you fully accept and assume all such risks and all responsibility for losses, costs and damages you incur as a result of my participation in the sport and this tournament.
18. You acknowledge, agree, represent and warrant that in consideration of being permitted to participate in this tournament, you hereby willingly assume all risks associated with participating in the sport including, but not limited to, falls, contact with other members, injuries that might arise from the use of the table tennis equipment or our club hall, all such risks being known to you and appreciated by you.
19. No claim will be recognized by TTTA should any player receive injury during participation in this tournament.
20. You acknowledge that you are in good health and in proper physical condition to participate in the sport and this tournament and that it is your responsibility to consult with my medical practitioner prior to participating to ensure that your participation will not pose any unusual risk to your health and wellbeing. You further agree that if at any time you believe conditions or equipment to be unsafe, you will immediately discontinue further participation in the sport.
21. Having read this agreement and knowing these facts, and in consideration of TTTA’s acceptance of your application to participate in this tournament, you for yourself and anyone entitled to participate in the sport on your behalf waive and release the TTTA Group from all claims (including future claims), demands, losses, damages and liabilities of any kind known or unknown, arising out of your use of and participation in the sport and this tournament and the facilities contained in the TTTA premises, including, but not limited to, claims for damages for personal injury and/or property damage, even though such liability or claim may arise out of the negligence or fault on the part of TTTA, and further, indemnify (and agree to keep indemnified) TTTA from and against any action, claim or other proceedings whatsoever brought against or incurred by TTTA (including legal costs on an indemnity basis) and including but not limited to any claim to any property real or personal or any claim in respect of injury to or death of any person and any losses, damages, liabilities or damages arising out of or in connection with any failure by you to perform or comply with any of the terms and conditions herein contained, any breach of any warranty by you as is herein contained, or any negligent or wilful acts or omissions by you.
