This membership entitles a player to participate in all our Association operations, including training sessions and senior fixtures.  A player with this level of membership can also participate in all Townsville tournaments held through the year, excluding the Townsville Open Championships (being a sanctioned tournament with our State governing body). A player on this membership level cannot compete in sanctioned tournaments. This includes another association open tournament, or any State and National Tournament.
<b>Social Senior Member</b>	\$65.00 <input type="checkbox"/>	This is a discounted membership available to social senior players only.  This level of membership entitles a player to participate in social senior fixtures on Monday, Wednesday and Friday of each week from 9am to 12pm. A Social Senior Member is able to participate in senior training sessions (Thursday night and the Saturday Women's only session) but is not otherwise able to participate in other operations of the Association, including senior fixtures or tournaments (unless the tournament is open to the public, like events in our International Women's Day Tournament and events in our Chinese New Year Tournament).  This membership level is designed to maintain a low membership cost for those players who may wish to participate in social seniors only.
<b>Non-Active Member</b>	Free <input type="checkbox"/>	This is a member who does not play table tennis but is still involved in our Association (whether it be through volunteering or otherwise). It enables someone to become a member and receive communication from our secretary, as well as certain other member benefits that may be offered.

<p>1. In these Standard Terms of Membership:            "TTTA" means Townsville Table Tennis Association Inc            "TTTA Group" means TTTA and its respective administrators, directors, agents, officers, officials, committee members, volunteers, employees, other participants, any sponsors, advertisers and if applicable, owners and lessors of premises on which the sport takes.            "you" or "your" means the member named in this membership application form and wherever relevant, includes such members minor child, personal representatives, assigns, heirs, and next of kin.</p> <p>2. You understand that by being a TTTA member you will operate under Rules, bylaws and policies of TTTA and Table Tennis Queensland (TTQ).</p> <p>3. You understand that TTTA is a family friendly environment with the consequence that a very high standard of behaviour is required.</p> <p>4. You understand the nature of table tennis activities and are aware that participating in a sport such as table tennis is potentially hazardous activity and contains risks. These risks may be caused by you and/or your minor child's own actions or inaction, or the actions or inaction of others participating in the sport. There may also be other risks and social and economic losses either not known to you or not readily foreseeable at this time and you fully accept and assume all such risks and all responsibility for losses, costs and damages you incur as a result of my participation in the sport.</p> <p>5. You acknowledge that you are in good health and in proper physical condition to participate in the sport and that it is your responsibility to consult with my medical practitioner prior to participating in the sport to ensure that your participation will not pose any unusual risk to your health and wellbeing. You further agree that if at any time you believe conditions or equipment to be unsafe, you will immediately discontinue further participation in the sport.</p> <p>6. Your membership includes insurance cover through our national governing body, Table Tennis Australia. However, we are not familiar with what, if any, insurance cover may be included in this policy of insurance. You acknowledge, agree, represent and warrant that in consideration of your membership being accepted by TTTA and being permitted to participate in the sport, you hereby willingly assume all risks associated with participating in the sport including, but not limited to, falls, contact with other members, injuries that might arise from the use of the table tennis equipment or our club hall, all such risks being known to you and appreciated by you.</p> <p>7. Having read this agreement and knowing these facts, and in consideration of TTTA's acceptance of your membership and permitting in you to participate in the sport, you for yourself and anyone entitled to participate in the sport on your behalf, waive and release the TTTA Group from all claims (including future claims), demands, losses, damages and liabilities of any kind known or unknown, arising out of your use of and participation in the sport and the facilities contained in the TTTA premises, including, but not limited to, claims for damages for personal injury and/or property damage, even though such liability or claim may arise out of the negligence or fault on the part of the TTTA Group.
